The finance facility is provided by China Shandong Jinshunda Group Co Limited, the company's major shareholder. The facility was amended on 9 April 2018 and now has a maximum drawdown of \$15,500,000 and is repayable by 30 September 2021. The finance facility now bears interest at the Commonwealth Government Bond Yield (GSBW21 maturing 21 December 2021) + 250 bps per annum.
